- a. LGROW has replaced their 10-year-old Natural Connections map with a new online interactive map. This map features different types of land use and green infrastructure (GI). Originally, LGROW was working on this map with the Sustainable Committee. They would now like to turn this map over to the Subwatersheds Committee because they will mainly utilize this map.
- b. Wendy has asked for the Subwatersheds to get us GI information if they have it and Deanna will get LGROW the address of the GI so they can be mapped. During the discussion of this map the Subwatersheds asked for my layers to be researched. Courtney will work on adding Contours, floatable waters, access points and BMP's. The Natural Connections map can be accessed through the link above or on LGROW's website in the stormwater tab under green infrastructure.

  - a. Wendy is working on a Watershed Reliance Plan. This plan will give a framework for how the watershed will respond to climate change. Many communities have created these plans, but Wendy will be making this plan larger to encompass the whole watershed.

## 6. Other Discussion

- a. Subwatershed Updates
  - i. Bass/Deer- Results are back from their *E. coli* source tracking they did last year. They are checking human *E. coli* to locate septic issues.
  - ii. Sand Creek EGLE 319 grant to reduce flooding. Several people have been working on implementing BMP's including cover crops and no till. This is occurring in the upper 9 miles of the creek and are Ag BMPs. Most of the project areas are close to completion. Ben can share progress shots if requested of the two stage ditches that they have been working on.
  - iii. Crockery Creek Is working on the planning stages for a 319 grant, and a road stage crossing grant. The board meeting is the week of April 27<sup>th</sup> via zoom. They will be discussing establishing a nonprofit and taking on an activity for the group.
  - iv. Thornapple River- They have received their RCPP Grant. This grant will focus on water quality work for the Grand and the Kalamazoo watersheds. They are still working on their septic replacement grant and are hopping to extend that grant until the end of November.
  - v. LGRW- GLRI grant received from the US forest service to increase tree canopies.
  - vi. Rush Creek- They have been able to focus on outreach and watershed material. They will still be working on an Earth Day Celebration this year. There is a signup calendar to allow people to still plant trees at a safe distance for Earth Day.



They are hoping to do a mussel survey in either July or August and would appreciate volunteers to help conduct the mussel surveys.

- vii. Plaster Creek Also received the GLRI forest service grant. EPA GLRI grant for more curb cut rain gardens. Most of their events have been postponed and are hoping to continue those later this summer. The director is retiring, and they will be going through some shifting this summer. Deanna will be holding a talk for the Creston neighborhood for Earth Day.
- viii. Coldbrook Creek Wege grant that they have received has helped them get off the ground. They have made their education and outreach focusing on the environment and joy in the environment. They are creating a more cohesive look and are making brochure and bumper stickers to match. They are working with TU to monitor park of their stream. A citizen science group will be working on a history and watershed tour for the watershed.
