 - 1. Tri-fold preferable, or half sheet, laminated? Cardstock?
 - 2. Lawn clippings need to be blown back onto grass, not into street, or collected and disposed of appropriately off site
 - 3. Use Phosphorus free fertilizer
 - 4. Benefits specific to communities (dangerous for motorcycles, can cause clogged storm drains and lead to flooding)
 - iii. Parking Lot Pollution
 - iv. Put Waste in its Place
 - v. Stop the Salt Assault
 - vi. Could use boating information (Spring Lake)
 - 1. SL had clean boat, clean water signs
- 5. Documenting successful implementation the Information and Education Plan of the federally-approved Lower Grand River Watershed Management Plan.
 - a. Round Table (Summer Events)
 - i. Gaines Twp adjacent- Kent County mixed material facility was approved
 - ii. GR- Alger ravine project is wrapping up and Plaster Creek Stewards are finishing planting, Highlands should be completed this fall, working on industrial stormwater program
 - iii. River Network- River Rally is coming up, Garfield Neighborhood Association has been putting together a litter taskforce, can promote AAD as an extension of that, hope to have a large agricultural project in Garfield Park
 - iv. EGLE- Student Earth Day webinar, Michigan EJ tool draft is out: <u>https://www.michigan.gov/environmentaljustice/0,9615,7-400-104480---,00.html</u> final draft of the MI Healthy Climate Plan will be released on April 22, 2022.
 - v. Spring Lake- working to get an invasive species removal contract

- vi. Groundswell- Green-Blue Career Fair
- vii. Kent Conservation District- chosen for the Rogue River Support Grant- working to provide 5 landowners with riparian buffers, and riparian outreach via EcoBuzz
- viii. Kent County Health Dept- seeing more septic permits as the weather gets warmer
- ix. Walker-new ordinance has been passed, working to rework the nested school agreement with Kenowa Hills Public Schools
- x. Georgetown- working on stormwater ord.
- xi. Plainfield- will start cross connection testing for residential irrigation and could use the lawn flier for this, Wolverine watermain extension is ongoing
- b. LGROW Committee Updates
 - i. Technical- June meeting cancelled, Prein & Newhof to do TMDL sampling
 - ii. Sustainability- working on the Lower Grand Water Trail
 - iii. Subwatershed- Jamboree will be held in Rush Creek in September
 - iv. SWOrd- next meeting May 5, almost all MS4s have adopted the new ordinance
